1. Summary of your Act and the Minister(s) responsible for it:

Canada Transportation Act S.C. 1996, c. 10 Assented to 1996-05-29

The Canada Transportation Act, 1996 was created to update the National Transportation Act, 1987 and the Railway Act and, in the process, to repeal some other acts that were no longer relevant. The goals were to make the railroad more commercial and improve service, to lessen regulation on the air transportation and motor vehicle industries, and to empower the Canadian Transportation Agency to oversee any regulations that were retained or altered, and to comply with the Canada Business Corporations Act and the Competition Act.

Minister of Transport administers the Act. At the time of Royal Assent, the Minister was Liberal MP the Hon. David Anderson.

A brief written description of your search strategy, including any problems you may have encountered. (10 points)

- a) I started of on the Justice Dept.'s website and it was quite easy to find the consolidated Act. It was harder to find the original Act since very little information was available on LEGISinfo. I ended up finding the dates in the Status of House business for the second session of the 35th Parliament. Then I could confirm the date of Royal Assent as well as MP who had been the Minister for Transport at that time.
- 2. Once I'd looked through the Justice Department website and LEGISinfo for the things with which I was familiar, I moved on to the Table of Public Statutes. I looked for the citations for these, beginning in the Annual Statutes for anything between 2001 and 2017. I then looked through the Canada Gazette Part III to find the names and text for the amending Acts between 1996 and 2000. That done, I still had questions about some of the CIF information, but at least I had the names and dates of all the amending acts. I left the CIF information for the moment and searched the more recent chapters of the Annual Statutes and found nothing related to this Act. That done, I went to LEGISinfo to look for anything that might be working its way through parliament. I looked for all the recent Acts that have received Royal Assent (chapters 9-14), none of which relate to this Act. I then looked through the most recent Canada Gazette Part II.
- 3. Then I began to tackle regulations. At first, I was confused by the differences between the list on the Justice Dept., Transport Canada, and the Consolidated Index websites. In the end, I went with the Consolidated Index. I then looked through the changes to our assigned regulation, pulling out all the amending SORs and looking them up in the Canada Gazette, Part II. It also took a while to be sure I was looking at the oldest version of the assigned regulation and not an updated one
- 4. Finally, in the Privy Council Office's Order in Council Database, I searched for anything between the latest Canada Gazette (June 28) and June 30 and found nothing.
- 5. The only thing I still feel uncertain about at the end of this assignment is the use of Sis: when they're necessary/relevant and how best to find them if they're not listed in the Table of Public Statutes. I feel that I can navigate the Table of Public Statutes and the Canada Gazette quite well, but feel much less confident about the PCO-OIC database.
